

The federal mail and wire fraud statutes, 18 U.S.C. 1341 and 1343, impose criminal penalties for the use of mail or interstate wire communications to further a scheme or artifice to defraud. In 1988, Congress enacted the honest services statute, 18 U.S.C. 1346, which amended the mail and wire fraud statutes to include within the definition of scheme or artifice to defraud frauds which deprive another of the intangible right of honest services. Based in part on case law predating its enactment, the statute has been interpreted to amend the mail and wire fraud statutes in cases arising in both the public and private sectors. It does not extend to non-pecuniary intangible rights other than the right of honest services. H.R. 1825, a bill introduced in the 111th Congress, would make the mail and wire fraud statutes applicable to other intangible rights. Types of fraudulent schemes which might be prosecuted using an honest services theory include, among other things, a corporate officer s attempt to defraud corporate shareholders, the bribery of a public official, or the failure of a public official to disclose a conflict of interest. Federal courts have noted various concerns--for example, a potential for excessive federal .
